## **Quick Start Guide**

This guide gets you started with a typical installation for IBM Case Manager

#### **Product overview**

IBM® Case Manager simplifies the job of designing and building a case management system and provides a client for case workers to easily manage cases. You design a case management solution that is based on closely related cases and then deploy that solution into a production environment. Case workers complete work items that are associated with cases.

#### 1 Step 1: Access the software and documentation


## 2 Step 2: Evaluate the hardware and system configuration



Use the Software Product Compatibility Reports page to generate a report for supported operating systems, related software, hypervisors, hardware requirements, and detailed system requirements, including component-level details. For more information, see System Requirements.

## 3 Step 3: Review the installation architecture

IBM Case Manager is deployed on a web application server (WebSphere® Application Server or Oracle WebLogic) and uses IBM Case Foundation or IBM Content Foundation to access and store content and assets. IBM Case Manager also requires IBM Content Navigator. The following graphic shows the typical architecture of IBM Case Manager in a distributed development environment and the features that IBM Case Manager can integrate with:



## 4 Step 4: Install or upgrade IBM Case Manager



You can install IBM Case Manager as a new installation or upgrade your Version 5.2.1 system or Version 5.3.0 system to Version 5.3.1. For instructions, see the following topics in the IBM Case Manager documentation:

#### 5 Step 5: Get started



After you install IBM Case Manager, you run the configuration tool to deploy the Case Manager Builder and Case Manager Client applications on the web application server. Use Case Manager Builder in a development environment to create and modify your case management solutions. After you deploy your solutions in a production environment, case workers access the solutions through the Case Manager Client.
