IBM<sup>®</sup> Event Streams is an event-streaming platform that is based on Apache Kafka. It helps you react to events in near real time for engaging client experiences. This update adds Linux<sup>®</sup> on IBM Z<sup>®</sup> to the existing set of platforms that are supported by Event Streams. You can now take advantage of existing IBM Z platform investment and extend your event backbone closer to your existing mainframe applications.
