Caution notices for the Storwize V3700

Ensure that you understand the caution notices for Storwize V3700.

CAUTION:

The battery contains lithium. To avoid possible explosion, do not burn or charge the battery.

Do not: Throw or immerse into water, heat to more than 100°C (212°F), repair or disassemble. (C003)

CAUTION:

Removing components from the upper positions in the rack cabinet improves rack stability during a relocation. Follow these general guidelines whenever you relocate a populated rack cabinet within a room or building.

- Reduce the weight of the rack cabinet by removing equipment starting at the top of the rack cabinet. When possible, restore the rack cabinet to the configuration of the rack cabinet as you received it. If this configuration is not known, you must observe the following precautions.
 - Remove all devices in the 32U position and above.
 - Ensure that the heaviest devices are installed in the bottom of the rack cabinet.
 - Ensure that there are no empty U-levels between devices installed in the rack cabinet below the 32U level.
- If the rack cabinet you are relocating is part of a suite of rack cabinets, detach the rack cabinet from the suite.
- If the rack cabinet you are relocating was supplied with removable outriggers they must be reinstalled before the cabinet is relocated.
- Inspect the route that you plan to take to eliminate potential hazards.
- Verify that the route that you choose can support the weight of the loaded rack cabinet. Refer to the documentation that comes with your rack cabinet for the weight of a loaded rack cabinet.
- Verify that all door openings are at least 760 x 230 mm (30 x 80 in.).
- Ensure that all devices, shelves, drawers, doors, and cables are secure.
- Ensure that the four leveling pads are raised to their highest position.
- Ensure that there is no stabilizer bracket installed on the rack cabinet during movement.
- Do not use a ramp inclined at more than 10 degrees.
- When the rack cabinet is in the new location, complete the following steps:
 - Lower the four leveling pads.
 - Install stabilizer brackets on the rack cabinet.
 - If you removed any devices from the rack cabinet, repopulate the rack cabinet from the lowest position to the highest position.
- If a long-distance relocation is required, restore the rack cabinet to the configuration of the rack cabinet as you received it. Pack the rack cabinet in the original packaging material, or equivalent. Also lower the leveling pads to raise the casters off the pallet and bolt the rack cabinet to the pallet.

(R002)

CAUTION:

- Rack is not intended to serve as an enclosure and does not provide any degrees of protection required of enclosures.
- It is intended that equipment installed within this rack will have its own enclosure. (R005).

CAUTION:

Tighten the stabilizer brackets until they are flush against the rack. (R006)

CAUTION: Use safe practices when lifting. (R007)

CAUTION:

Do not place any object on top of a rack-mounted device unless that rack-mounted device is intended for use as a shelf. (R008)

If the rack is designed to be coupled to another rack only the same model rack should be coupled together with another same model rack. (R009)

- Do not open or service any power supply assembly.
- Do not connect or disconnect any cables or perform installation, maintenance, or reconfiguration of this product during an electrical storm.
- The product might be equipped with multiple power cords. To remove all hazardous voltages, disconnect all power cords.
- Connect all power cords to a properly wired and grounded electrical outlet. Ensure that the outlet supplies proper voltage and phase rotation according to the system rating plate.
- Connect any equipment that will be attached to this product to properly wired outlets.
- When possible, use one hand only to connect or disconnect signal cables.
- Never turn on any equipment when there is evidence of fire, water, or structural damage.
- Disconnect the attached power cords, telecommunications systems, networks, and modems before you open the device covers, unless instructed otherwise in the installation and configuration procedures.

To disconnect:

- 1. Turn off everything (unless instructed otherwise).
- 2. Remove the power cords from the outlets.

- 4. Remove all cables from the devices.

To connect:

- 1. Turn off everything (unless instructed otherwise).
- 2. Attach all cables to the devices.
- **3.** Attach the signal cables to the connectors.
- 4. Attach the power cords to the outlets.
- 5. Turn on the devices.
- Sharp edges, corners and joints might be present in and around the system. Use care when handling equipment to avoid cuts, scrapes and pinching. (D005)

The PROTECTIVE EARTHING CONDUCTORS should be terminated at that point. A recognized or certified closed loop connector (ring terminal) should be used and secured to the frame with a lock washer using a bolt or stud. The connector should be properly sized to be suitable for the bolt or stud, the locking washer, the rating for the conducting wire used, and the considered rating of the breaker. The intent is to ensure the frame is electrically bonded to the PROTECTIVE EARTHING CONDUCTORS. The hole that the bolt or stud goes into where the terminal conductor and the lock washer contact should be free of any non-conductive material to allow for metal to metal contact. All PROTECTIVE EARTHING CONDUCTORS should terminate at this main protective earthing terminal or at points marked with $\frac{1}{4}$. (R010)

Special caution and safety notices

This information describes special safety notices that apply to the Storwize V3700. These notices are in addition to the standard safety notices supplied and address specific issues relevant to the equipment provided.

General safety

When you service the Storwize V3700, follow general safety guidelines.

Use the following general rules to ensure safety to yourself and others.

- Observe good housekeeping in the area where the devices are kept during and after maintenance.
- Follow the guidelines when lifting any heavy object:
 - 1. Ensure that you can stand safely without slipping.
 - 2. Distribute the weight of the object equally between your feet.
 - **3**. Use a slow lifting force. Never move suddenly or twist when you attempt to lift.
 - 4. Lift by standing or by pushing up with your leg muscles; this action removes the strain from the muscles in your back. *Do not attempt to lift any objects that weigh more than 18 kg (40 lb) or objects that you think are too heavy for you.*
- Do not perform any action that causes a hazard or makes the equipment unsafe.

- Before you start the device, ensure that other personnel are not in a hazardous position.
- Place removed covers and other parts in a safe place, away from all personnel, while you are servicing the unit.
- Keep your tool case away from walk areas so that other people cannot trip over it.
- Do not wear loose clothing that can be trapped in the moving parts of a device. Ensure that your sleeves are fastened or rolled up above your elbows. If your hair is long, fasten it.
- Insert the ends of your necktie or scarf inside clothing or fasten it with a nonconducting clip, approximately 8 cm (3 in.) from the end.
- Do not wear jewelry, chains, metal-frame eyeglasses, or metal fasteners for your clothing.

Remember: Metal objects are good electrical conductors.

- Wear safety glasses when you are hammering, drilling, soldering, cutting wire, attaching springs, using solvents, or working in any other conditions that might be hazardous to your eyes.
- After service, reinstall all safety shields, guards, labels, and ground wires. Replace any safety device that is worn or defective.
- Reinstall all covers correctly after you have finished servicing the unit.

Handling static-sensitive devices

Ensure that you understand how to handle devices that are sensitive to static electricity.

Attention: Static electricity can damage electronic devices and your system. To avoid damage, keep static-sensitive devices in their static-protective bags until you are ready to install them.

To reduce the possibility of electrostatic discharge, observe the following precautions:

- Limit your movement. Movement can cause static electricity to build up around you.
- Handle the device carefully, holding it by its edges or frame.
- Do not touch solder joints, pins, or exposed printed circuitry.
- Do not leave the device where others can handle and possibly damage the device.
- While the device is still in its antistatic bag, touch it to an unpainted metal part of the system unit for at least two seconds. (This action removes static electricity from the package and from your body.)
- Remove the device from its package and install it directly into your Storwize V3700, without putting it down. If it is necessary to put the device down, place it onto its static-protective bag. (If your device is an adapter, place it component-side up.) Do not place the device onto the cover of the Storwize V3700 or onto a metal table.
- Take additional care when you handle devices during cold weather. Indoor humidity tends to decrease in cold weather, causing an increase in static electricity.

Important information:

- This guide presumes that you have read the planning information regarding your physical environment that is available from the Storwize V3700 Knowledge Center.
- Ensure that any cables that you are supplying are available for installation.

Installation scenarios

Depending on your order, this documentation steps you through setting up your system for the following scenarios:

- Setting up a new system that consists of a control enclosure only. In this case, you are not installing any expansion enclosures.
- Setting up a new system that consists of a control enclosure and one or more expansion enclosures.
- Adding an expansion enclosure to an existing system. In this case, you initially installed a control enclosure (and, optionally, one or more expansion enclosures). You want to add an expansion enclosure to your existing system. You do not need to power off the system. You can add an expansion enclosure while the system is operational.






Figure 1. Rear view of a Storwize V3700 control enclosure

Figure 1 shows the rear view of a control enclosure and identifies the location of the power supply units and node canisters.

Data ports




Figure 2. Data ports in the rear of the Storwize V3700 control enclosure

Figure 2 shows the rear view of a Storwize V3700 control enclosure and identifies the location of the ports.

- **1** USB ports. Each canister has two USB ports. One port is used during installation.

 - **Port 1** Must be connected for system management. Can optionally be used for iSCSI host connectivity.
 - **Port 2** Optional. Can be used for iSCSI host connectivity or to provide an alternative (redundant) management address.
- Serial-attached SCSI (SAS) ports. Each canister has four SAS ports. Ports 1 to 3 are optionally used for connecting to host systems. Port 4 is optionally used for connecting to expansion enclosures.

Control enclosure support rails




Figure 3. Control enclosure support rails of a Storwize V3700 system

The left and right control enclosure support rails (Figure 3 on page 8) are designed specifically for installation of a control enclosure.

- The ledge on the inside of the rails supports the entire length of a control enclosure.
- At the rear end of the control enclosure support rail, the top edge curves over to capture the top edge of an inserted control enclosure. This prevents the installed control enclosure bouncing when the rack is subjected to quake or vibration.
- The control enclosure support rails adjust to fit racks from 685 mm to 765 mm deep, measured between the front and rear rack rails.

Expansion enclosure components




Figure 4. Rear view of a Storwize V3700 expansion enclosure

Figure 4 shows the rear view of an expansion enclosure. The location of the power supply units and expansion canisters are identified, as follows.

- **2** Power supply units




Figure 5. SAS ports and LEDs in rear view of a Storwize V3700 expansion canister

Each canister has two SAS ports that are numbered 1 on the left and 2 on the right. Port 1 is always used. Port 2 is used only if this is not the last enclosure in the chain.

Expansion enclosure support rails




Figure 6. Expansion enclosure support rails on Storwize V3700

The left and right expansion enclosure support rails (Figure 6) are designed specifically for installation of an expansion enclosure.

- The ledge on the inside of each rail supports the entire length of an expansion enclosure.
- The expansion enclosure support rails capture the left and right rear edges of an inserted expansion enclosure. This prevents the installed control enclosure bouncing when the rack is subjected to quake or vibration.
- The expansion enclosure support rails adjust to fit racks from 595 mm to 755 mm deep, measured between the front and rear rack rails.

This section describes the additional information you need to know when using the DC power models.






Figure 8. Direct current power supply unit connectors and indicators

The LEDs have a comparable meaning to the LEDs on the AC power supply. Problem diagnosis and service procedures are the same. For details, see "Powering on the system" on page 50.

Connecting a DC power supply to a DC power source

A Storwize V3700 enclosure that is DC powered contains two DC power supply units (PSUs). Each unit must be connected to a suitable -48V DC power source. To provide redundancy in a power circuit failure, connect the two PSUs to different DC power sources.

Use the supplied cables to connect the DC PSUs to the power sources. Use only the IBM supplied DC power cable (IBM part number 00AR087) to connect the unit to a DC power source.

Each PSU cable must be protected by a 20A circuit breaker. These instructions assume that the circuit breaker is separate from the DC power distribution unit. Refer to the DC power distribution unit documentation and the circuit breaker

documentation for details. Follow the instructions that are given there for connecting the circuit breaker to the power distribution unit and for connecting the DC power cable to the circuit breaker.

One end of the cable ends in a plug that fits the DC PSU. At the other end of the cable, each individual wire ends with a 6 mm diameter ring terminal that is designed to fit an M6 stud. Provide adequate strain relief after you attach the ring terminals to the power source. Table 8 lists the wire colors.

The DC power cable is 4 m long. Connect it to the DC power source before you connect it to the PSU. The PSU does not have a power switch, so its outputs and the enclosure become live as soon as power is connected.

The supplied power must meet the input requirements that are listed in Table 9.

The connection to the DC power source must be made by trained service personnel. Ensure that the connection is made in accordance with all the requirements of the equipment that is being used.

The DC power cable must be totally contained in a single rack and must not extend outside the rack to another rack.

If it is necessary to replace the ring terminals with a different connector, choose a suitably sized and rated UL-listed connector that is appropriate for the wire gauge and available current. Install the ring terminals according to the instructions provided by the manufacturer.

Direct current power replaceable units

The DC power supply model has two replaceable units.

Description	FRU part number	Customer replaced

Table 10. Direct current power replaceable units

The procedure to remove and replace the DC power supply unit is the same as the AC power supply procedure.

When replacing the DC power cable, follow the instructions for disconnecting cables from the DC power distribution unit.

Verify environmental requirements

The environmental and electrical requirements for the physical site must be met to ensure that your system works reliably.

Before installing a Storwize V3700 system, you must verify that adequate space in a suitable rack is available. You must also ensure that the requirements for power and environmental conditions are met.

This guide assumes that you have completed the physical planning for the environment of your system. If you have not done the environmental planning for your system, see the "Storwize V3700 physical installation planning" topic in the Storwize V3700 IBM Knowledge Center for Storwize V3700.

Review enclosure location guidelines

Before installing the enclosures, you must be familiar with these enclosure location guidelines.

Installing a control enclosure only

If you are installing a control enclosure only, follow these guidelines.

- Position the enclosure in the rack so that you can easily view it and access it for servicing.
- Locate the enclosure low enough for the rack to remain stable.
- Ensure that you provide a way for two or more people to install and remove the enclosure.

Installing a control enclosure and one or more expansion enclosures

If you are installing a control enclosure plus one or more expansion enclosures, follow these guidelines.

- Each Storwize V3700 enclosure to be installed requires 2U of rack space.
- Each assembled enclosure weighs more than 18 kg. There must be sufficient space at the front of the rack for two persons to carry the enclosure safely.
- Install all enclosures that constitute one system in contiguous positions in a rack. Place the control enclosure at the top.
- Each control enclosure supports connection to up to nine expansion enclosures. If this system installation has fewer than nine expansion enclosures, reserve space directly below the system to allow future expansion.
- If a rack is to be only partially filled, install the enclosures low enough for the rack to remain stable and enable easy access to the enclosures for servicing.

Adding an expansion enclosure to an existing system

If you are adding an expansion enclosure to an existing system, follow these guidelines.

- You do not need to power off the system. You can add an expansion enclosure while the system is operational.
- Add the first expansion enclosure directly below the control enclosure.
- Add the second expansion enclosure directly above the control enclosure.
- · Add the third expansion enclosure directly below the first.

• Add the fourth expansion directly above the second, and so on.

Chapter 2. Installing the hardware

After verifying that you have all of the hardware components that you require, you can install them.

You have completed the initial steps of verifying the shipping contents and becoming familiar with the hardware components. You have verified that the power and environmental requirements are met and have planned the location of the enclosures. You are now ready to begin installing the hardware components and connecting the data cables and power cords.

NEBS compliant earth connection

When installing enclosures into a Network Equipment-Building System (NEBS) compliant installation, each enclosure must have a reliable electrical earth connection that is separate to any earth connections provided by power supply cables.

On Storwize V3700 enclosures, this connection is made via the front enclosure mounting screws that are part of the standard installation described in "Installing the support rails" and "Installing the enclosures" on page 24. To provide a reliable electrical earth connection, the upright mounting rails of the racks into which enclosures are installed must meet the following requirements prior to installing the support rails and enclosures:

- Upright mounting rails must not be painted, oxidized or otherwise insulated from the enclosure flanges and mounting rails. If paint, oxidization or other insulation is present, it must be removed and the metal must be brought to a bright, non-corroding finish.
- Upright mounting rails must have their own NEBS compliant connection to earth, independent of the earth connections provided by any power supply cables.

Note: If the Storwize V3700 system is required to be NEBS compliant, some system configuration settings must be made. For details, see "Configuring a Storwize V3700 system to be NEBS compliant" on page 62.

Installing the support rails

Before installing an enclosure, you must first install support rails.

About this task

Note: For NEBS compliant installations, additional requirements are placed on the rack into which the support rails and enclosures are to be installed. Before proceeding, ensure that the rack meets the requirements listed in "NEBS compliant earth connection."

Procedure

To install the support rails, complete the following steps.




Figure 9. Rack mounting rails and screws

1. Locate the rack mounting rails and screws (Figure 9). The rail assembly consists of two rails that must be installed in the rack cabinet.

- 2. Remove the springs that are taped to one of the rails.
- **3**. Attach a spring to the outside of each rail.




Figure 10. Installing the rail spring

 - a. Attach the circle end of the spring around the stud on the rail. (See Figure 10 on page 21.)
 - b. Pulling on the spring, attach the hook end of the spring to the tab on the rail.




Figure 11. Hole locations in the front of the rack

4. Working at the front of the rack cabinet, identify the two standard rack units (2U) of space in the rack into which you want to install the support rails. Figure 11 shows two rack units with the front mounting holes identified.

- 1 Upper rail mounting bracket pin
- 2 Lower rail mounting bracket pin

- **3** Rack mounting screw hole
- 5. Ensure that the appropriate bracket pins are installed in the front and rear bracket of each rail. Each rail comes with four medium pins preinstalled (two in the front bracket and two in the rear bracket). Large and small pins are provided separately. Use the pins that are appropriate for the mounting holes in your rack (see Table 11).

Table 11. Selecting bracket pins for your rack

Mounting holes	Bracket pins
Round, unthreaded	Use the preinstalled medium pins.
Round, threaded	Unscrew the medium pins and replace with the smaller pins supplied with the rails.
Square	Unscrew the medium pins and replace with the large pins supplied with the rails.




Figure 12. Opening the hinge brackets

6. At each end of the rail, grasp the tab **1** and pull *firmly* to open the hinge bracket (see Figure 12).

- 7. Align the holes in the rail bracket with the holes on the front and rear rack cabinet flanges. Ensure that the rails are aligned on the inside of the rack cabinet.
- **8**. On the rear of the rail, press the two bracket pins into the holes in the rack flanges.




Figure 13. Closing hinge brackets and installing rear screw

- **9**. Close the rear hinge bracket to secure the rail to the rack cabinet flange. (See Figure 13.)

- **10.** On the front of the rail, press the two bracket pins into the holes in the rack flanges.
- 11. Close the front hinge bracket to secure the rail to the rack cabinet flange. (See Figure 13.)
- **12.** Secure the rear of the rail to the rear rack flange with an M5 screw. (See Figure 13.)
- 13. Repeat the steps to secure the opposite rail to the rack cabinet.
- 14. Repeat the procedure to install rails for each additional enclosure.

Installing the enclosures

Following your enclosure location plan, install the control enclosure (and optionally, one or more expansion enclosures).

About this task

Note: For NEBS compliant installations, more requirements are placed on the rack into which the support rails and enclosures are to be installed. Before you proceed, ensure that the rack meets the requirements that are listed in "NEBS compliant earth connection" on page 19.

CAUTION:

- To lift and install the enclosure into the rack requires at least two people.
- Load the rack from the bottom up to ensure rack stability. Empty the rack from the top down.

Procedure

To install an enclosure, complete the following steps.

- 1. On either side of the drive assemblies, remove the enclosure end caps by grasping the handle and pulling the bottom of the end cap free, then clearing the tab on the top of the enclosure.
- 2. Align the enclosure with the front of the rack cabinet.




Figure 14. Inserting the enclosure

- **3**. Carefully slide the enclosure into the rack along the rails until the enclosure is fully inserted (see Figure 14 on page 25).

Note: The rails are not designed to hold an enclosure that is partially inserted. The enclosure must always be in a fully inserted position.

- 4. Secure the enclosure with a screw in the rack mounting screw hole.
- 5. Reinstall the left and right end caps. (See Figure 14.) The left end cap has indicator windows that align with the status LEDs (light-emitting diodes) on the edge of the enclosure.
 - a. Ensure that the serial number of the end cap matches the serial number on the rear of the enclosure.
 - b. Fit the slot on the top of the end cap over the tab on the chassis flange.
 - c. Rotate the end cap down until it snaps into place.
 - d. Ensure that the inside surface of the end cap is flush with the chassis.

Installing options in the control enclosure

If you have purchased host interface adapters or cache memory upgrades for your control enclosure and those options were not preinstalled for you, you must open each node canister and install the options.

Note: You must install the same options in all node canisters.

First, open the canister as described in "Opening the node canister." Then refer to the procedure for the option you are installing.

- "Installing an 8 Gbps Fibre Channel 4-port host interface adapter" on page 28
- "Installing a 10 Gbps iSCSI-FCoE 2-port host interface adapter" on page 30
- "Installing a 1 Gbps iSCSI 4-port host interface adapter" on page 32
- "Installing a SAS 4-port host interface adapter" on page 34
- "Installing an 8 GB cache memory update" on page 35

Finally, close the canister and install it in the control enclosure (see "Closing the node canister" on page 38).

Note: Disk drives can also be installed in the control enclosure, but that procedure does not involve opening any node canisters. See "Installing disk drives" on page 40 for details.

Opening the node canister

Before you can install options in a node canister, you must gain access by opening the canister cover.

Procedure

To open the canister, complete the following steps.




Figure 15. Removing a node canister

- 1. If the canister is already installed in the enclosure, remove it as shown in Figure 15 on page 27.
 - a. Unlatch the release levers and pull them open. The canister moves out of the slot approximately 0.6cm (0.25 inch).
 - b. Slide the canister out of the enclosure.




Figure 16. Removing the canister cover

- 2. Turn the canister over and open the cover as shown in Figure 16.
 - a. Press the recessed blue touch points on the cover.
 - b. Slide the cover away from the thumbscrew end of the canister.

Installing an 8 Gbps Fibre Channel 4-port host interface adapter

If you purchased an FC ACHK 8 Gbps Fibre Channel 4-port host interface adapter that was not preinstalled for you, you must install it in the node canister.

Before you begin

The 8 Gbps Fibre Channel 4-port host interface adapter is installed in the node canisters in the control enclosure. If your control enclosure has two node canisters, you must install the same options in *both* canisters. Do not start installation until you have *two* of the 8 Gbps Fibre Channel 4-port host interface adapter options.

About this task

Note: The host interface adapter has four ports, but only two small form-factor pluggable (SFP) transceivers are installed.

Procedure

To install the host interface adapter, complete the following steps.




Figure 17. Host interface adapter and SFP transceivers

1. Remove the SFP transceivers from the host interface adapter (Figure 17). To remove an SFP transceiver, swing the release handle open and use it to pull the transceiver out of the port.




Figure 18. Installing 8 Gbps Fibre Channel 4-port host interface adapter

2. Loosen the retaining thumbscrew **1** as shown in Figure 18.

- **1** Retaining thumbscrew
- 2 Filler handle
- **3** Host interface adapter
- 4 Catch slot
- 3. From inside the canister, grasp the filler handle **2** and slide the filler plate toward the thumbscrew to disengage the plate from the catch slot **4**.
- 4. Remove the filler plate.
- 5. Insert the host interface adapter **3** into the canister as shown in Figure 18
- 6. Align the mounting bracket of the host interface adapter with the inside of the host interface adapter aperture at the thumbscrew end of the canister, ensuring that the tab at the end of the faceplate is aligned with the catch slot4.
- 7. Align the connecting edge of the host interface adapter with the slot in the host interface adapter connector inside the canister.

- **8**. Apply pressure to the opposite edge of the host interface adapter to push the adapter into the connector.
- 9. Check that the host interface adapter is installed squarely in its slot and tighten the retaining thumbscrew **1**.
- **10.** Reinstall the SFP transceivers. To install a transceiver, push it fully into the port and close the release handle.
- **11**. If you purchased the additional 2-transceiver option, install the extra SFP transceivers in the remaining ports.

Installing a 10 Gbps iSCSI-FCoE 2-port host interface adapter

If you purchased an FC ACHM 10 Gbps iSCSI-FCoE 2-port host interface adapter that was not pre-installed for you, you must install it in the node canister.

Before you begin

The 10 Gbps iSCSI-FCoE 2-port host interface adapter is installed in the node canisters in the control enclosure. If your control enclosure has two node canisters, you must install the same options in *both* canisters. Do not start installation until you have *two* of the 10 Gbps iSCSI-FCoE 2-port host interface adapter options.

Procedure

To install the host interface adapter, complete the following steps.

- 1. Remove each SFP transceiver from the host interface adapter. To remove an SFP transceiver, swing the release handle open and use it to pull the transceiver out of the port.
- 2. Remove the filler plate from the host interface adapter slot.




Figure 19. Installing 10 Gbps iSCSI-FCoE 2 port host interface adapter

 - a. Loosen the retaining thumbscrew **1** as shown in Figure 19 on page 31.

- **1** Retaining thumbscrew
- 2 Filler handle
- **3** Host interface adapter
- 4 Catch slot
- b. From inside the canister, grasp the filler handle **2** and slide the filler plate toward the center of the canister to disengage the plate from the catch slot.
- c. Remove the filler plate.
- 3. Insert the 10 Gbps iSCSI-FCoE 2-port host interface adapter 3 into the canister as shown in Figure 19.
- 4. Align the mounting bracket of the host interface adapter with the inside of the host interface adapter aperture (adjacent to the thumbscrew), ensuring that the tab at the end of the faceplate is aligned with the catch slot.
- 5. Align the connecting edge of the host interface adapter with the slot in the host interface adapter connector inside the canister.
- **6.** Apply pressure to the opposite edge of the host interface adapter to push the adapter into the connector.

- Check that the host interface adapter is installed squarely in its slot and tighten the retaining thumbscrew 1.
- **8**. Reinstall the SFP transceivers that were removed in step 1 on page 30. To install a transceiver, push it fully into the port and close the release handle.

Installing a 1 Gbps iSCSI 4-port host interface adapter

If you purchased an FC ACHL 1 Gbps iSCSI 4-port host interface adapter that was not pre-installed for you, you must install it in the node canister.

Before you begin

The 1 Gbps iSCSI 4-port host interface adapter is installed in the node canisters in the control enclosure. If your control enclosure has two node canisters, you must install the same options in *both* canisters. Do not start installation until you have *two* of the 1 Gbps iSCSI 4-port host interface adapter options.

Procedure

To install the host interface adapter, complete the following steps.




Figure 20. Installing 1 Gbps iSCSI 4-port host interface adapter

1. Loosen the retaining thumbscrew **1** as shown in Figure 20 on page 33.

- **1** Retaining thumbscrew
- 2 Filler handle
- **3** Host interface adapter
- 4 Catch slot
- 2. From inside the canister, grasp the filler handle **2** and slide the filler plate toward the center of the canister to disengage the plate from the catch slot.
- **3**. Remove the filler plate.
- 4. Insert the host interface adapter **3** into the canister as shown in Figure 20.
- 5. Align the mounting bracket of the host interface adapter with the inside of the host interface adapter aperture at the rear of the canister, ensuring that the tab at the end of the faceplate is aligned with the catch slot.
- 6. Align the connecting edge of the host interface adapter with the slot in the host interface adapter connector inside the canister.
- 7. Apply pressure to the opposite edge of the host interface adapter to push the adapter into the connector.
- 8. Check that the host interface adapter is installed squarely in its slot and tighten the retaining thumbscrew 1.

Installing a SAS 4-port host interface adapter

If you purchased an FC ACHJ SAS 4-port host interface adapter that was not pre-installed for you, you must install it in the node canister.

Before you begin

The SAS 4-port host interface adapter is installed in the node canisters in the control enclosure. If your control enclosure has two node canisters, you must install the same options in *both* canisters. Do not start installation until you have *two* of the SAS 4-port host interface adapter options.

Procedure

To install the host interface adapter, complete the following steps.




Figure 21. Installing SAS 4-port host interface adapter

1. Loosen the retaining thumbscrew **1** as shown in Figure 21.

- **3** Host interface adapter
- 4 Catch slot
- 2. From inside the canister, grasp the filler handle **2** and slide the filler plate toward the center of the canister to disengage the plate from the catch slot.
- **3**. Remove the filler plate.
- 4. Insert the host interface adapter **3** into the canister as shown in Figure 21 on page 34.
- 5. Align the mounting bracket of the host interface adapter with the inside of the host interface adapter aperture at the rear of the canister, ensuring that the tab at the end of the faceplate is aligned with the catch slot.
- 6. Align the connecting edge of the host interface adapter with the slot in the host interface adapter connector inside the canister.
- 7. Apply pressure to the opposite edge of the host interface adapter to push the adapter into the connector.
- 8. Check that the host interface adapter is installed squarely in its slot and tighten the retaining thumbscrew 1.

Installing an 8 GB cache memory update

If you purchased an FC ACHB 8 GB Cache Update option that was not pre-installed for you, you must install it.

Before you begin

The 8 GB Cache Update option is installed in the node canisters in the control enclosure. If your control enclosure has two node canisters, you must install the same options in *both* canisters. Do not start installation until you have *two* of the Cache Update options.

About this task

The Cache Update option consists of a 4 GB memory module. When added to a node canister, it increases the total memory in the canister to 8 GB.




Figure 22. Where to install the cache memory update

The memory module is inserted into memory slot 2, located between the existing memory module and the battery (Figure 22 on page 36).

Procedure

To install the memory module option, complete the following steps.




Figure 23. Installing memory module option

1. Open the retaining clip on each end of the memory module connector as shown in Figure 23 on page 37.

Attention: To avoid breaking the retaining clips or damaging the memory module connectors, open and close the clips gently.

- **2.** Touch the static-protective package that contains the memory module to any unpainted metal surface on the outside of the canister.
- 3. Remove the memory module from the package.
- 4. Turn the memory module so that the keys align correctly with the connector.
- 5. Insert the memory module into the connector by aligning the edges of the module with the slots at the ends of the connector (see Figure 23).
- 6. Firmly press the memory module straight down into the connector by applying pressure on both ends of the module simultaneously. The retaining clips snap into the locked position when the module is firmly seated in the connector.

Note: If you can see a gap between the module and the retaining clips, the module has not been correctly inserted. Open the retaining clips, remove the module, and then reinsert it.

Closing the node canister

After installing options in a node canister, you must close the canister cover and install the canister in the control enclosure.

Procedure

To close the canister, complete the following steps.




Figure 24. Reinstalling the canister cover

- 1. Reinstall the cover as shown in Figure 24.
 - a. Align the four hook slots on the cover with the pins on the canister.
 - b. Slide the cover toward the latch and release levers until it locks into place.




Figure 25. Installing a node canister

- **2**. Turn the canister over and install it in the control enclosure as shown in Figure 25.
 - **a**. With the latch and release levers fully extended, slide the canister into the enclosure until the levers begin to move inwards.
 - b. Simultaneously close both latch and release levers.

Installing disk drives

If you purchased disk drives that were not preinstalled for you, you must install them.

About this task

Drives can be installed in the control enclosure or any of the expansion enclosures. The installation procedure is the same for either enclosure type.

Install all the drives you require before configuring the system. This allows the best provisioning of drives into arrays.

Procedure

To install a drive, complete the following steps.




Figure 26. Removing a filler panel

- 1. Remove the filler panel from the slot into which you want to install the drive (as shown in Figure 26).
 - a. Grip the front of the filler panel **1** and pull firmly to remove it from the the drive slot.
 - b. Save the filler panel for future use.

- **1** Filler panel
- **2**. Touch the static-protective package that contains the drive to any unpainted surface on the outside of the enclosure.
- **3**. Remove the drive from the package.




Figure 27. Installing a drive

- 4. Install the drive in the empty slot as shown in Figure 27.
 - a. Ensure that the drive-tray handle is in the open (unlocked) position.
 - b. Align the drive assembly with the guide rails in the slot.
 - c. Gently push the drive assembly into the slot until the drive stops.
 - d. Rotate the drive handle to the closed (locked) position.

Connecting SAS cables to expansion enclosures

If you have installed expansion enclosures, you must connect them to a control enclosure.

Before you begin

If you purchased disk drives that were not preinstalled for you, you must install all of the drives **before** connecting the SAS cables to the expansion enclosures.

About this task

This task applies if you are installing one or more expansion enclosures. You can attach up nine expansion enclosures to the control enclosure.

Note: When connecting SAS cables between enclosures, you must follow a list of guidelines to ensure that your configuration is valid. Do not begin connecting the cables until you have read the "SAS cabling guidelines" topic.

Procedure

To install the cables, complete the following steps.




Figure 28. Connecting the SAS cables

- 1. Using the supplied SAS cables, connect the control enclosure to the first expansion enclosure as shown in Figure 28.
 - **a**. Connect SAS port 4 of the left node canister in the control enclosure to SAS port 1 of the left expansion canisters in the first expansion enclosure.
 - b. Connect SAS port 4 of the right node canister in the control enclosure to SAS port 1 of the right expansion canisters in the first expansion enclosure.

- 2. If additional expansion enclosures are installed, connect each one to the previous expansion enclosure as shown in Figure 28 on page 42.
 - a. Use one cable to connect SAS port 2 of the left expansion canister in the previous expansion enclosure to SAS port 1 of the left expansion canister in the newly installed expansion enclosure.
 - b. Use the second cable to connect SAS port 2 of the right expansion canister in the previous expansion enclosure to SAS port 1 of the right expansion canister in the newly installed expansion enclosure.

Note: A control enclosure can support up to nine expansion enclosures.

SAS cabling guidelines

When connecting SAS cables between enclosures, you must follow a list of guidelines to ensure that your configuration is valid.

Orienting the connector




Figure 29. SAS cable connectors

When inserting SAS cables, make sure the connector (Figure 29) is oriented correctly.

- The orientation of the connector must match the orientation of the port before you push the connector into the port. The cable connector and socket are keyed, and it is important that you have proper alignment of the keys when the cable is inserted.
- The blue pull tab must be **below** the connector.
- Insert the connector **gently** until it clicks into place. If you feel resistance, the connector is probably oriented the wrong way. Do **not** force it.
- When inserted correctly, the connector can only be removed by pulling the tab.
- When both ends of a SAS cable are inserted correctly, the green link LEDs next to the connected SAS ports are lit.

Guidelines

Be aware of the following guidelines when you begin to attach the cables to the SAS ports.

• No more than nine expansion enclosures can be chained to port 4 of a node canister.

- No cable can be connected between a port on a left canister and a port on a right canister.
- A cable must not be connected between ports in the same enclosure.
- Port 4 of a control enclosure is not cabled to another control enclosure.
- Attach cables serially between enclosures. Do not skip an enclosure.
- The last enclosure in a chain must not have cables in port 2 of canister 1 and port 2 of canister 2.
- A connected port on the node canister must connect to a single port on an expansion canister. Cables that split the connector out into separate physical connections are not supported.
- Ensure that cables are installed in an orderly way to reduce the risk of cable damage when replaceable units are removed or inserted.
- Arrange your cables to provide access to the following items:

USB ports

USB port access is required when you use a USB flash drive to configure the system.

Enclosures

Access is required to the hardware for servicing and for safely removing and replacing components using two or more people.

Connecting Ethernet cables to node canisters

To provide system management connectivity for your Storwize V3700 system, you must connect Ethernet cables to Ethernet port 1 of each node canister in the control enclosure. This connection can optionally also be used for iSCSI host connection. Ethernet port 2 can optionally be connected to provide a second system management address, a second iSCSI host connection, or both.

Procedure

To install the Ethernet cables, complete the following steps.




Figure 30. Connecting the Ethernet cables

1. Connect Ethernet port 1 of each node canister in the system to the IP network that will provide connection to the system management interfaces, as shown in Figure 30. This port can also be used for iSCSI connectivity to the system by hosts on the network. Where more than one control enclosure is present in the system, ensure port 1 of every node canister is connected to the same network to provide access if the configuration node fails.

2. Optionally, connect Ethernet port 2 of each node canister in the system to a second IP network that will provide redundant connection to the system

management interfaces, as shown by the lighter cable connection in Figure 30 on page 44. This port can also be used for iSCSI connectivity to the system by hosts on the network. If there is more than one control enclosure in the system, ensure that port 2 of every node canister is connected to the same network to provide access if the configuration node fails.

Connecting Ethernet cables to 1 Gbps iSCSI 4-port host interface adapters

If you installed 1 Gbps iSCSI 4-port host interface adapters, you can use Ethernet cables to connect them to your Ethernet SAN.

About this task

The Ethernet port numbering on the host interface adapter starts at 3, because Ethernet ports one and two are built into the canister.

Note: The Ethernet cables are connected in pairs. Both canisters must have the same number of cables connected.

Procedure

To install the cables, complete the following steps.

- 1. Identify the correct pair of Ethernet cables for the Ethernet ports labeled 3 in the left canister and the right canister.
- 2. Connect the appropriate cable to each port.
- **3**. For each additional pair of Ethernet ports in the right and left canisters, identify the correct pair of cables and connect them.

Results




Figure 31. Example configuration with two pairs of Ethernet cables connected to 1 Gbps iSCSI 4-port host interface adapters

Figure 31 shows an example configuration with a pair of Ethernet cables connected to port 3 in each canister, and another pair connected to port 4 in each canister.

Connecting fibre cables to a 10 Gbps iSCSI-FCoE 2-port host interface adapter

If your Storwize V3700 system has 10 Gbps iSCSI-FCoE 2-port host interface adapters installed, you can use fibre cables to connect them to your 10 Gbps Ethernet or FCoE SAN.

About this task




Figure 32. Example configuration with two pairs of Ethernet cables connected to 10 Gbps iSCSI-FCoE 2-port host interface adapters

1. Connect the required number of Fibre Channel cables. Refer to the "Planning" section of the information center for instructions on determining the number of cables required.




Figure 33. Example configuration with two Fibre Channel cables per canister

Note: Both canisters must have the same number of cables connected. Figure 33 shows an example configuration with two Fibre Channel cables connected to each canister.




Figure 34. Example configuration with four Fibre Channel cables per canister




Figure 35. Mini SAS HD to Mini SAS HD cable




Figure 36. Mini SAS HD to Mini SAS cable

• Mini SAS HD to Mini SAS (Figure 36)

Note: When inserting SAS cables, make sure that the connector is oriented correctly.

- When connecting to the SAS ports on the left side of the node canister, the blue pull tab must be **below** the connector.
- When connecting to a SAS 4-port host interface adapter, the blue pull tab must be **above** the connector.
- Insert the connector **gently** until it clicks into place. If you feel resistance, the connector is probably oriented the wrong way. Do **not** force it.
- When inserted correctly, the connector can only be removed by pulling the tab.

Procedure

 - The enclosures themselves. Access is required to the hardware for servicing and for safely removing and replacing components using two or more people.




Figure 37. Example configuration with three SAS cables per canister




Figure 38. Example configuration with two SAS cables connected to a SAS 4-port host interface adapter

Powering on the system




Figure 39. Expansion canister LEDs



Note: Each enclosure has two power supply units. To provide power failure redundancy, connect the two power cords to separate power circuits.

5. From the rear of the control enclosure, check the LEDs on each node canister (see Figure 40).

Chapter 3. Configuring the system

Configuring your system is necessary in two situations: when you power up a new system for the first time, and when you add an expansion enclosure to an existing system.

After initializing the system, you will use the Storwize management GUI to complete the configuration procedures.

Configuring a Storwize V3700 system to be NEBS compliant

For operation in Network Equipment-Building System (NEBS) compliant installations, the Storwize V3700 system can be configured to extend its operational temperature range to meet NEBS operating temperature requirements.

Note: The Storwize V3700 system might not be able to save its cache and state data if the power fails while it is operating within the extended temperature range. This is because the battery capacity decreases as temperature rises. If the save of cache and state data cannot be completed, an extended service action is required to recover the system and data might be lost. Keep the temperature within the normal operating range if possible, and maintain a reliable power supply.

- To extend the operational temperature range of all enclosures in the system to meet NEBS operating temperature requirements, enter the following CLI command:
 - ${\tt chsystem}\ {\tt -hightempmode}\ {\tt on}$

Once set, high_temp_mode will be be applied to all enclosures in the system.

• To configure the default operating temperature ranges, enter the following CLI command:

chsystem -hightempmode off

• To determine which mode is currently configured, read the value of the high_temp_mode parameter in the **lssystem** output.

Note: Configuring the Storwize V3700 system to be NEBS compliant only changes the way the system responds to raised temperature. You must also ensure that the way the system is racked, and the operating environment, conforms to NEBS requirements. (See "NEBS compliant earth connection" on page 19.)

When you add an expansion enclosure to an existing system, you must use the Storwize management GUI to update the system configuration.

About this task
