



**IBM SmartCloud for Government**

**List Price Schedule - United States in U.S. dollars**

**Effective Date: August 27, 2012**

This Charges Schedule provides the current IBM charges and rates applicable for the Services acquired from IBM and provided under the terms of the IBM SmartCloud for Government Agreement, including its Attachments. Capitalized terms used herein have the same meaning as set forth in the IBM SmartCloud for Government Agreement. Charges are exclusive of any duty, tax, levy, or fee.

**1. Cloud Infrastructure as a Service (IaaS)**

Charges depend on the options selected in terms of CPU usage, OS instances, and GB of memory.

Monthly charges for a Customer selected Instance begins when the Instance is made available for use (provisioned), and ends when the Instance is cancelled (deprovisioned) -- based on the number of months of usage. IBM will invoice and Customer agrees to pay these monthly usage charges.

**1.1.1 Cloud Services – Virtual Machine CPU**

Charges are based on the GHz of vCPU allocation to the Customer's VM as follows:

<b>Charge per GHz per month</b>
\$ 81.78

**1.1.2 Cloud Services – OS Instances**

Charges are based on the number of OS instances used according to the following schedule:

<b>OS</b>	<b>Charge per instance per month</b>
Linux	\$ 54.22
Windows	\$ 61.83

**1.1.3 Cloud Services – Virtual Machine Memory**

Charges are based on the GB of memory allocated to the Customer's VM as follows:

<b>Charge per GB per month</b>
\$ 5.70

**2. Additional Services**

**2.1 Cloud Storage & Storage Management**

Charges for storage solutions are based on the total GB of allocated disk storage as follows:

<b>Cloud Storage</b>	<b>Storage Management</b>

**2.2 Backup Management**

Charges for backup administration and restoration of client data are based on the total GB of allocated disk storage undergoing backup

<b>Charge per GB per month</b>
\$ 0.27

### 2.3 Remote Access VPN

Remote Access VPN Customers are charged for the total number of VPN accounts concurrently allocated each month based on the highest total number of accounts allocated during the month according to the following:

<b>Charge per account per month</b>
\$ 28.94

### 2.4 Systems Administration

For each Customer OS instance managed, both production and non-production, the following charge applies:

<b>Charge per operating system instance per month</b>
\$ 354.29

### 2.5 Enterprise System Monitoring (ESM)

ESM charges are based on the number of devices registered in the monitoring system, actively monitored, and configured to send events to the event management system.

<b>Charge per device per month</b>
\$ 147.41

### 2.6 Security Engineering

Management and administration of security systems, devices, and zones is charged on a per item basis as follows:

<b>Charge per item per month</b>
\$ 1038.53

### 2.7 Security Operations Center (SOC)

SOC charges depend on the number of devices to be monitored (including firewalls, NIDS, servers, network devices, and systems with security agents on them) according to the following schedule:

<b>Charge per device per month</b>
\$ 226.26

### 2.8 Unbundled Dedicated Firewall

Management of an IBM provided dedicated firewall instance that is attached to SmartCloud for Government is charged based on the firewall size according to the following schedule:
