

# IPLA Sub-Capacity Overview

This website contains the list of sub-capacity eligible z Systems IPLA programs in the z/OS operating system family. Each eligible z/OS program is grouped into one of three categories: Execution-Based, Reference-Based, or z/OS-Based. The applicable type of sub-capacity terms per z Systems IPLA program is determined solely by IBM. Subsequent z Systems IPLA sub-capacity program announcements will indicate the type of sub-capacity terms, if applicable. Only one type of sub-capacity terms may apply per program.

Sub-Capacity terms on z Systems IPLA are only available to customers who qualify and implement Sub-Capacity for their respective z/OS MLC software and comply with all other IBM Terms and Conditions.

## Sub-Capacity Eligibility

To be eligible for sub-capacity charging on select z Systems IPLA programs in the z/OS operating system family, you must first implement and comply with all terms of either sub-capacity Advanced Workload License Charges (AWLC), sub-capacity Advanced Entry Workload License Charges (AEWLC), sub-capacity Workload License Charges (WLC), sub-capacity Entry Workload License Charges (EWLC), sub-capacity z Systems New Workload License Charges (zNALC), or Country Multiplex License Charges (CMP). To implement sub-capacity a machine must be z Systems (or equivalent). On that machine:

- All instances of the OS/390 operating system must be migrated to the z/OS (or z/OS.e) operating systems
- Any licenses for the OS/390 operating system must be discontinued
- All instances of the z/OS or z/OS.e operating systems must be running in z/Architecture (64-bit) mode

For that machine, you must create and submit an SCRT Sub-Capacity Report or an SCRT Multiplex Report to IBM each month. SCRT Reports must be generated using the Sub-Capacity Reporting Tool (SCRT). ## Sub-Capacity Contracts

You must comply with all of the terms of the sub-capacity offering, whichever is applicable:

- The complete terms and conditions of sub-capacity AWLC are defined in the IBM Customer Agreement - Attachment for IBM z Systems Advanced Workload License Charges (Z125-8538).
- The complete terms and conditions of sub-capacity AEWLC are defined in the IBM Customer Agreement - Attachment for IBM z Systems Advanced Entry Workload License Charges (Z125-8755).

- The complete terms and conditions of sub-capacity WLC are defined in the IBM Customer Agreement - Attachment for IBM z Systems Workload License Charges (Z125-6516).
- The complete terms and conditions for sub-capacity EWLC are defined in the IBM Customer Agreement - Attachment for EWLC, TWLC, zELC and z/OS.e License Charges (Z125-6587).
- The complete terms and conditions for sub-capacity zNALC are defined in the IBM Customer Agreement - Attachment for zNALC License Charges on IBM z Systems (Z125-7454).
- The complete terms and conditions for sub-capacity CMP are defined in the IBM Customer Agreement - Attachment for IBM Country Multiplex Pricing (Z126-6965)

Additionally, you must sign and comply with the terms and conditions specified in the amendment to the IPLA contract – either 'Amendment for IBM z Systems Programs Sub-Capacity Pricing (Z125-6929-02 or higher)' or 'Amendment for IBM Sub-Capacity for One-Time Charge Programs with Country Multiplex Pricing (Z126-6968)' as applicable. Once the amendment is signed, the terms in the amendment replace any and all previous z Systems IPLA sub-capacity terms and conditions.
