This contract is a part of the State of Missouri and IBM NASPO ValuePoint Contract number MNWNC-116 and is for use by State Agencies only.

Contract CT170046001 is awarded by the State of Missouri consisting of the following documentation that is available on NASPO ValuePoint's website at http://www.naspovaluepoint.org/#/contract-details/52/overview/general:

- The attached Contract #MNWNC-116, signed by the State of Minnesota and IBM Corporation
- ❖ The attached RFP #19512 issued by the State of Minnesota on 11/18/13 consisting of 139 pages.
- The attached Participating Addendum

The contractor shall provide the server and storage hardware, software, and related services outlined below in the contract utilization requirements at the firm, fixed discounts agreed to in the computer equipment contract established by the State of Minnesota and IBM Corporation based on NASPO ValuePoint contract #MNWNC-116. All references to the State of Minnesota's Department of Administration's Materials Management Division and NASPO ValuePoint, in the attached documentation shall be deemed to refer to the State of Missouri with the exception of information specific to the State of Minnesota and NASPO ValuePoint such as background information, statistical/factual information, etc.

Contract Utilization Requirements:

Prices reflect list price and the contract's discounts per unit of one (1). The state agency must check with IBM or an approved IBM Business Partner to learn more about discounts for volume or establishing standard configurations.

The NASPO Master Agreement has established configuration limits. Configuration is defined as the combination of hardware and software components that make up the total functioning system. Software purchases are considered as a part of the configuration limit of the equipment. The state has elected to use the configuration limit of \$1,500,000.00 per single configuration.

Systems & Servers

IBM's Power Systems Server Solutions include operating systems, systems software, services support, and training for System P, System I, and Linux Platforms.

Storage Solutions

IBM's Storage Solutions include disk storage, flash storage, hybrid storage, software defined storage, storage area networks (SAN), tape and virtual tape storage, and optical storage connected to IBM Power Systems.

Maintenance & Services

Maintenance and Support Services are available from IBM and approved IBM Business Partners for all products eligible to be sold under your state's Participating Addendum. Prices are determined based on the products and options selected.

Support Services available include, but are not limited to, warranty services, maintenance, installation, deinstallation, factory integration (software or equipment components), asset management, recycling/disposal, training and certification, pre-implementation design, disaster recovery planning and support, service desk/help desk, and any other directly related technical support service required for the effective operation of a product offered or supplied.

Software

IBM's Software Solutions include new License and Subscription & Support software and distributed software which runs on IBM Power Systems which may be purchased on premise as either perpetual licenses or subscription based licenses including software as a service.

Software such as middleware which is not always installed on the equipment, but is related to storage and server equipment purchased, is allowed and may be procured after the initial purchase of equipment.

Invoicing:

The contractor shall submit invoices for products and services provided for the State of Missouri to the address included on the state agency's purchase order.

Affidavit of Work Authorization and Documentation:

Pursuant to section 285.530, RSMo, if the contractor meets the section 285.525, RSMo, definition of a "business entity" (http://www.moga.mo.gov/mostatutes/stathtml/28500005301.html?&me=285.530) the contractor must affirm the contractor's enrollment and participation in the E-Verify federal work authorization program with respect to the employees hired after enrollment in the program who are proposed to work in connection with the services requested herein. The contractor should complete applicable portions of Exhibit A, Business Entity Certification, Enrollment Documentation, and Affidayit of Work Authorization. The applicable portions of Exhibit A must be submitted prior to an award of a contract.

Contractor's Personnel:

The contractor shall only employ personnel authorized to work in the United States in accordance with applicable federal and state laws. This includes but is not limited to the Illegal Immigration Reform and Immigrant Responsibility Act (IIRIRA) and INA Section 274A.

If the contractor is found to be in violation of this requirement or the applicable state, federal and local laws and regulations, and if the State of Missouri has reasonable cause to believe that the contractor has knowingly employed individuals who are not eligible to work in the United States, the state shall have the right to cancel the contract immediately without penalty or recourse and suspend or debar the contractor from doing business with the state. The state may also withhold up to twenty-five percent of the total amount due to the contractor.

The contractor shall agree to fully cooperate with any audit or investigation from federal, state, or local law enforcement agencies.

If the contractor meets the definition of a business entity as defined in section 285.525, RSMo, pertaining to section 285.530, RSMo, the contractor shall maintain enrollment and participation in the E-Verify federal work authorization program with respect to the employees hired after enrollment in the program who are proposed to work in connection with the contracted services included herein. If the contractor's business status changes during the life of the contract to become a business entity as defined in section

285.525, RSMo, pertaining to section 285.530, RSMo, then the contractor shall, prior to the performance of any services as a business entity under the contract:

- (1) Enroll and participate in the E-Verify federal work authorization program with respect to the employees hired after enrollment in the program who are proposed to work in connection with the services required herein; AND
- (2) Provide to the Division of Purchasing the documentation required in the exhibit titled, <u>Business Entity Certification</u>, <u>Enrollment Documentation</u>, and <u>Affidavit of Work Authorization</u> affirming said company's/individual's enrollment and participation in the E-Verify federal work authorization program; AND
- (3) Submit to the Division of Purchasing a completed, notarized Affidavit of Work Authorization provided in the exhibit titled, <u>Business Entity Certification</u>, <u>Enrollment Documentation</u>, and Affidavit of Work Authorization.

In accordance with subsection 2 of section 285.530, RSMo, the contractor should renew their Affidavit of Work Authorization annually. A valid Affidavit of Work Authorization is necessary to award any new contracts.
