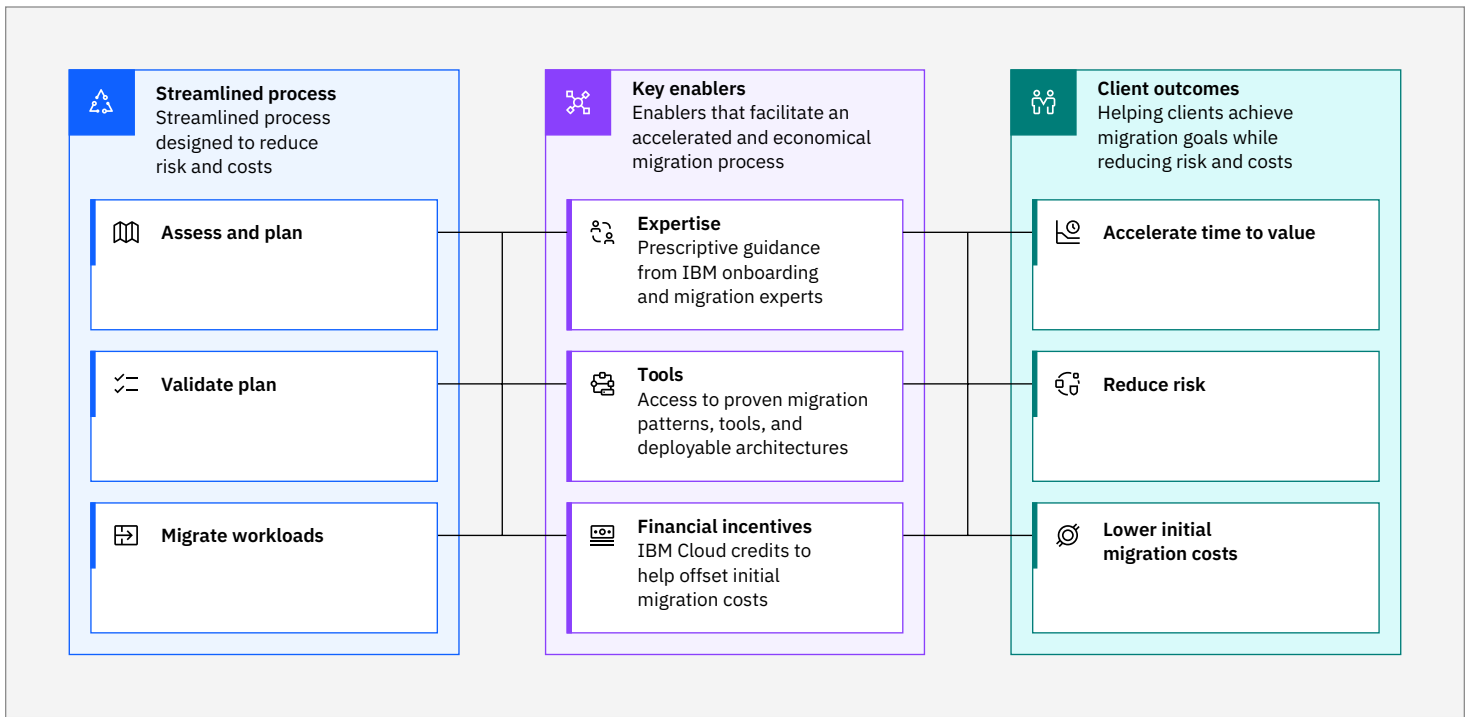

If you choose to engage a qualified partner to perform the migration, they're also eligible to receive migration incentives.
