

# Infoprint XT Version 3 Release 1.0 for z/OS, Program Number 5655-O15

Infoprint XT Version 3 Release 1 for  $z/OS^{\$}$ , hereafter referred to as Infoprint XT, is a data stream transform for the z/OS operating system that uses  $IBM^{\$}$  Xerox transform (XT) technology to convert Xerox metacode and Line Conditioned Data Stream (LCDS) application data to an Advanced Function Presentation (AFP) format.

# **Specified Operating Environment**

#### **Machine Requirements**

Infoprint XT runs on any IBM processor that can run z/OS Version 1 Release 12 or later.

#### **Programming Requirements**

Infoprint XT runs on the z/OS 1.12 (5694-A01) or later operating system.

You can optionally use these programs with Infoprint XT:

- PSF Version 4 Release 3 or later for z/OS (5655-M32) is required to print AFP documents on IPDS printers.
- Infoprint Server for z/OS (an optional feature of z/OS) is required to:
  - Run Infoprint XT without having to specify it as a JCL step.
  - Use IBM Print Transforms from AFP for Infoprint Server for z/OS (afpxpcl, afpxps, or afpxpdf) to convert AFP output to PCL, PDF, or PostScript (5655-TF1, 5655-TF2, or 5655-TF3).
- IBM Content Manager OnDemand for z/OS, Version 8 Release 4 or later (5697-N93), or IBM Content Manager OnDemand for Multiplatforms, Version 8 Release 5 or later (5724-J33), is required to archive and retrieve AFP documents.
